The courses are aimed at people wanting to learn more about the stock market and are available to both AIA members and non members.

COURSE 1: This one day introduction to the stock market assumes no previous knowledge of investing or of the stock market but course attendees should have read the introductory booklet, sent to them by email prior to the course. The introductory booklet covers the basics of investing, including many of the pitfalls which lead to losses by investors.

COURSE 2: This one day advanced course assumes some familiarity with both fundamental and technical analysis and some investing experience.

Here is a great opportunity to introduce a member of your family, a friend or colleague to the world of investing.

COURSE 1 – Saturday, 3 March 2012 AN INTRODUCTION TO INVESTING IN THE SHARE MARKET

Aimed at those who wish to start investing in the stock market but are uncertain how to go about it, or who perhaps want a brief refresher course.

The course will provide:-

- An overview of the stock market
- An understanding of the need for an investment plan and risk management
- An outline the role of fundamental and technical analysis in investing
- Methods for controlling trade entry, trade management and trade exit
- A review of methods for stock selection, record keeping and investment analysis.

The course will include examples of investing approaches, leading to a greater understanding. By the end of this course participants can expect to have an overview of the important tools and methods that investors use to successfully invest in the stock market and commence investing.

COURSE 2 – Sunday, 4 March 2012 STRATEGIES FOR IMPROVING INVESTMENT SUCCESS IN THE SHARE MARKET

Aimed at those who have experience of investing in the stock market, and have a general understanding of fundamental and technical analysis.

The course will provide:-

- Detailed analysis of market and specific risk
- An understanding of “position of the market”
- Some specific applications of indicators
- An outline of how to manage open positions
- A review of investor psychology
- Insights into the importance of time.

By the end of the course participants can expect to have a greater grasp of market analysis, trade entry and exit and management of open positions.

Participants are welcome to attend one or both courses. You need not attend Course 1 to attend Course 2. However, if attending both courses, please note there may be some overlap of material covered.
